1. Describe your plan for use of these funds including, if applicable, a project timeline:

I am respectfully requesting to be considered for the Meet-A-Need grant in the amount of \$500. If selected to receive grant money, I plan on using the funds to purchase engaging, hands on literacy materials to support sight word acquisition and phonological awareness in my kindergarten classroom. My goal is to use less paper/pencil activities and to use more play based activities that are developmentally appropriate for 5-6 year olds. In addition, my goal is to provide differentiated activities for the wide range of abilities within my classroom. Exposing students to different word work materials would allow them opportunities to collaborate through play as well as work on different words that are at their skill level.

In my classroom we have 75 minutes for reading. I plan on purchasing sight word and phonological awareness materials and games for students to choose from during this reading block while I work with small groups of students. I will also be having volunteers from Washington Reading Corp and United Way use these materials to work one-on-one with students who need additional support in sight word acquisition and phonological awareness.

2. Briefly describe how the students in your classroom and/or school will benefit from this project:

Kindergarten students learn best through hands on activities/play based activities. Students are also highly motivated by choice. Although we have a wonderful reading curriculum, there are no hands on materials provided to teachers that support students in learning sight words and phonological awareness. Students struggle with learning sight words and developing phonological awareness without repeated practice and exposure. If students have access to engaging and hands on materials vs. paper/pencil tasks, they will be excited about learning new words and skills. Their learning will become self-motivated and self-directed.

The materials will allow students to engage in daily play based activities where they are practicing their weekly sight words and phonological awareness skills. By using these materials, students will develop automaticity in

recognizing and reading their sight words and will gain a solid phonological awareness foundation which will in turn increase their fluency and overall confidence in reading and writing.

Lakeshore-Learning Sight Words Activity Chest-includes activity mats, foam letters, word tiles so students can match, find, build and write sight words. 49.99
